

**TENDER NOTIFICATION**

**FOR SETTING UP OF TEMPORARY CRACKER SHOPS FOR DIWALI SEASON  
AT BAPUGHAT LANGARHOUSE, HYDERABAD**

The tender is hereby called for bidders to set up 18 (eighteen) Nos temporary cracker shops on the eve of Deepawali festival for a period of five (5) days w.e.f. 26.10.2016 to 30.10.2016 at open ground in the Bapughat premises, Langarhouse, Hyderabad as per lay out plan. Tender documents should be submitted on or before 14.10.2016 at 03.00 p.m. tenders will be opened at 04.00 p.m. same day.

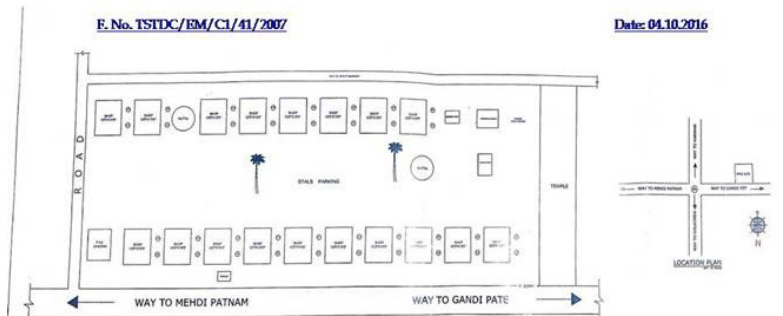
**Terms and conditions :**

- 1) The permission granted above is subject to strict adherence of the following conditions by each shop holder:
- 2) The bidders should undertake to comply with all the statutory provisions of laws in force including but not limited to the relevant permissions from Police, fire services, GHMC and any other statutory authority having jurisdiction in the scheduled place.
- 3) The bidder should himself run the shop and should not sublease or outsource to others. If found violating this condition the bidder will be stopped from running the shop immediately and blacklisted/banned in future.
- 4) Each shop holder should obtain a demand draft for Rs.10,000/- (Rupees Ten thousand only) in favour of Managing Director, TSTDC, Hyderabad towards ground rent for a period of (5) days from 26.10.2016 to 30.10.2016.
- 5) Each shop holder should deposit Rs.25,000/- (Rupees Twenty five thousand only) towards security deposit, which is interest free and refundable on vacating the shop without any damage.
- 6) Each shop holder should establish his shop with temporary structures in the area specified for each shop. No permanent construction is permitted and **handle with only three (3) persons.**
- 7) The shop holder shall not utilize the space for any other activity other than those permitted above.
- 8) Each shop holder should obtain necessary license / permission from the concerned Departments before establishing the shops. Failing which this permission will be deemed to be cancelled.

- 9) The fireworks shall be kept in a shed made of non-flammable material which is closed and secured so as to prevent unauthorized persons having access thereto.
- 10) The sheds for possession and sale of fireworks shall be kept at a distance of at least 3 meters from each other and 50 meters from any protected works.
- 11) The sheds shall not be facing each others.
- 12) No oil burning lamps, gas lamps or naked lights shall be used in the shed or within the Safe distance of the sheds for the purpose of lightening. Any electrical light, if used shall be fixed to the wall or ceiling should not be suspended by flexible wire. Switches should be fixed rigidly near the ceiling and a master switch should be provided for each row of sheds.
- 13) Display of fireworks shall not be allowed within 50 meters of any shed.
- 14) Each shop holder should handover the space back to the Asst General Manager, (AMC) TSTDC, Corporate Office, duly clearing by 31.10.2016 Noon. If the shop holder fails to clear the space, the same will be got done from out of the security deposit.
- 15) Tender Forms can be purchased from AGM (AMC) 3<sup>rd</sup> floor TSTDC, Himayathnagar Hyderabad for an amount of Rs. 1,000/- cash or DD in the name of TSTDC along with the applicable taxes.
